3. All works if applicable, must comply with current Building and Water Regulations.
4. The contractor has ensured, during demolition work, no distress or movement to walls, floors and roof to the subject and adjoining building.
5. All structural concrete to be grade C35 UNO
6. All Structural steel to be grade S275 UNO.
7. All Steel to be covered with 2 layers of 12.5mm plasterboard to achieve 30 min fire resistance.
8. All supporting walls and structural works to be read in conjunction with structural engineer's details. structural steelwork (where used) to meet current building regulations.
9. This drawing has been prepared solely for the purposes of obtaining either Planning Permission and or Building Reg approval. Unless marked as such (in Red) the drawing is not suitable for construction purposes, and it may be necessary to augment and / or amend the drawing for this purpose.

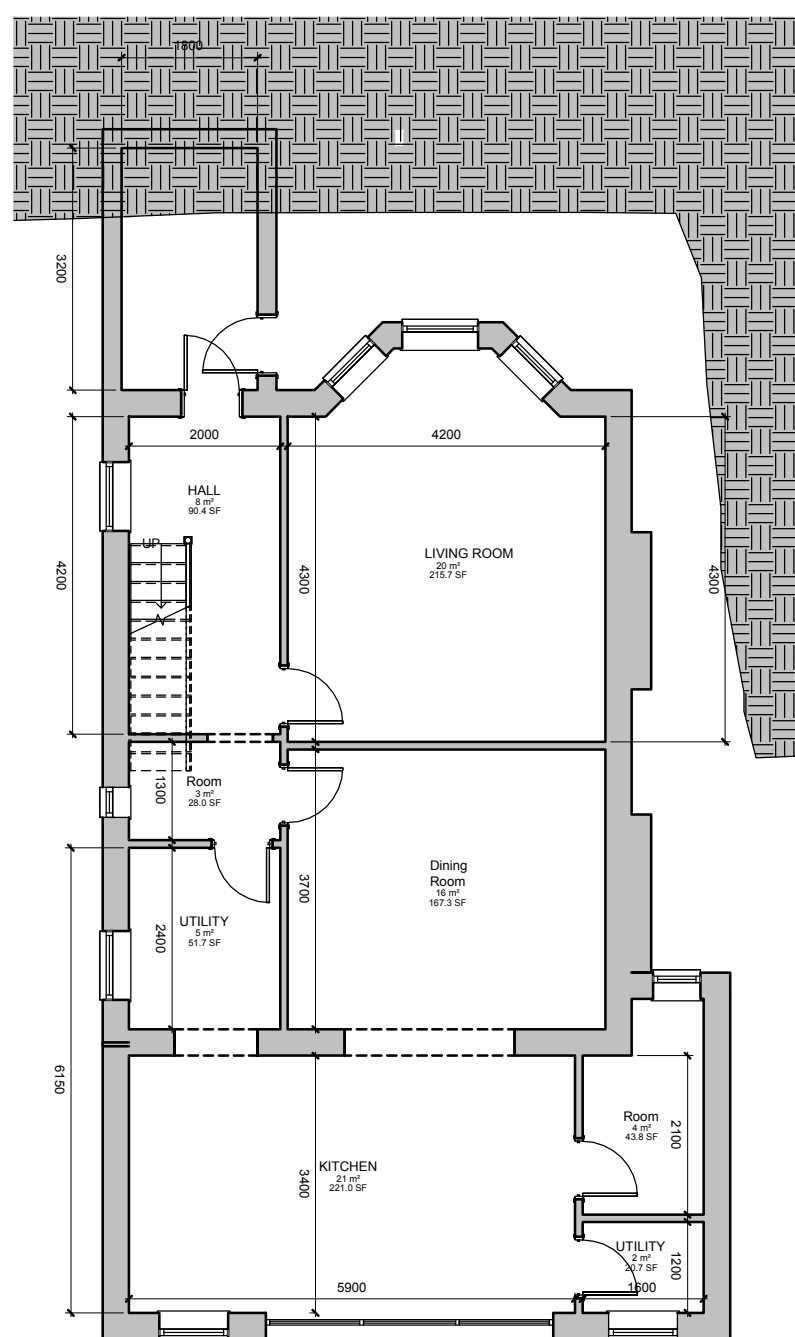

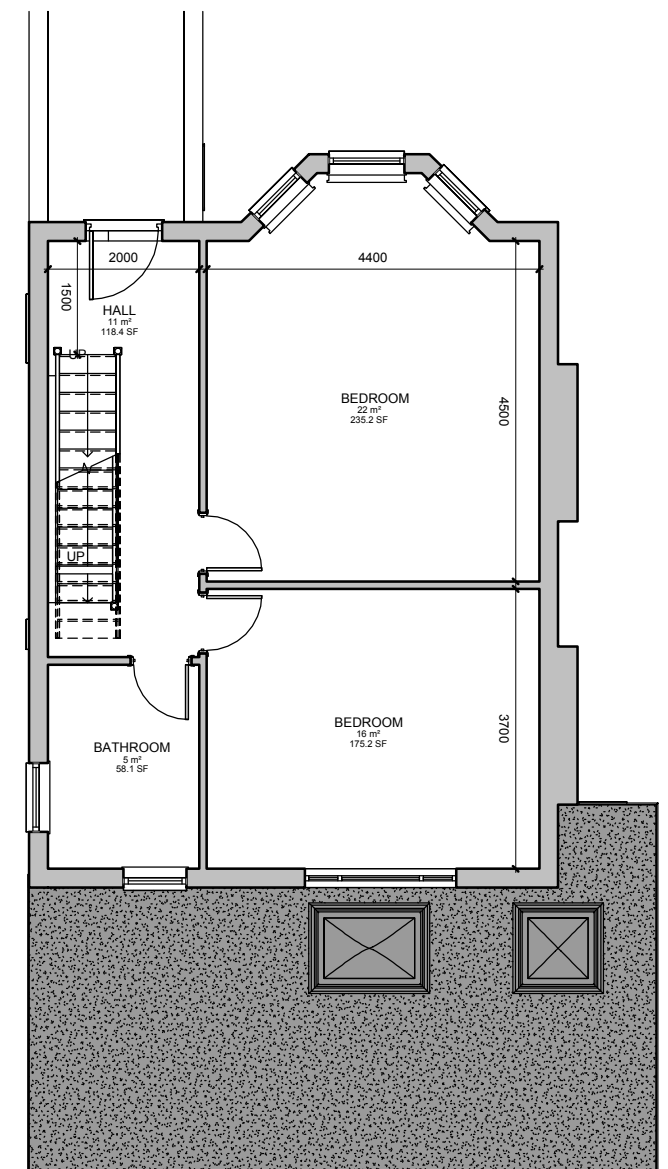

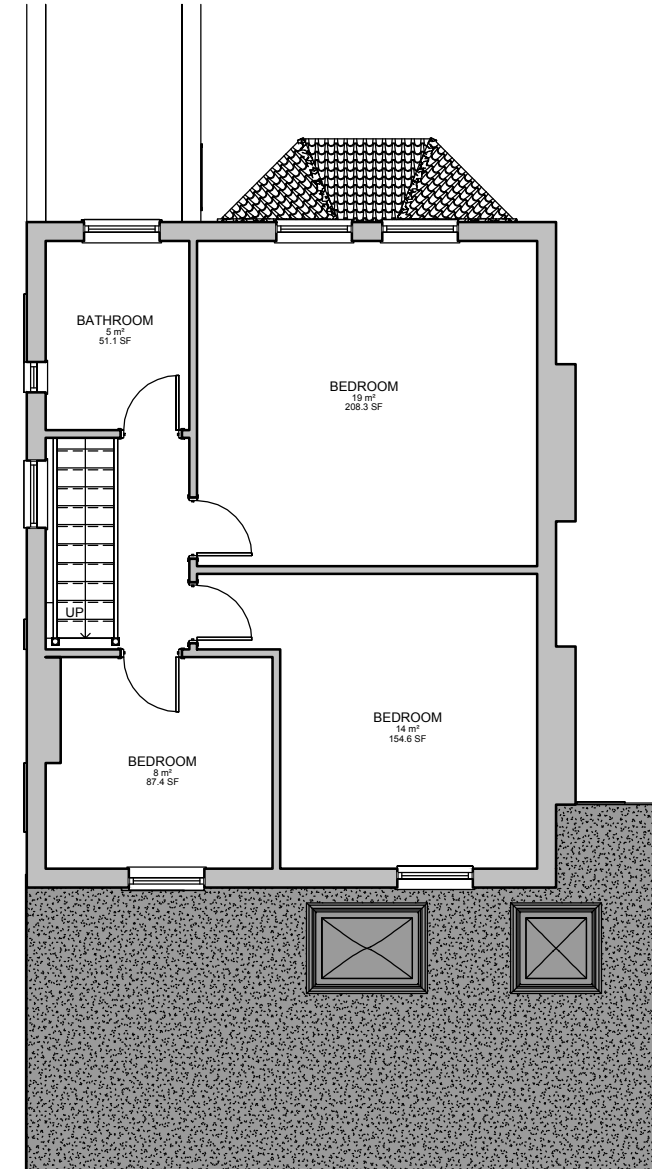
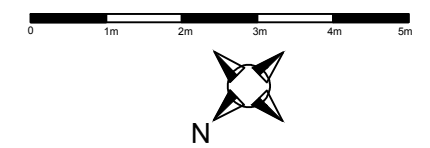


1 EXISTING BASEMENT 88m2
