## A: Property Register

This register describes the land and estate comprised in the title.

- 1 (12.04.1988) The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being 3 New Close, London (SW19 2SX).
- 2 The Transfer dated 29 February 1988 referred to in the Charges Register was made pursuant to Part V of the Housing Act 1985 and the land has the benefit of and is subject to such easements as are granted and reserved in the said Deed and the easements and rights specified in paragraph 2 of Schedule 6 of the said Act.
- 3 The Transfer dated 29 February 1988 referred to above also contains provisions as to light or air boundary structures and other matters.

## B: Proprietorship Register

This register specifies the class of title and identifies the owner. It contains any entries that affect the right of disposal.

- 2 (26.02.2021) The price stated to have been paid on 29 January 2021 was £455,000.
- 3 (26.02.2021) The Transfer to the proprietor contains a covenant to observe and perform the covenants referred to in the Charges Register and of indemnity in respect thereof.
- 4 (29.11.2022) RESTRICTION: No disposition of the registered estate by the proprietor of the registered estate is to be completed by registration without a certificate signed by a conveyancer that the conveyancer is satisfied that (1) the company which executed the document submitted for registration as disponor is the same company as the proprietor, and (2) reasonable steps have been taken to establish that each person who signed as an officer of the company held the stated office at the time of execution.

## C: Charges Register

- 3 (27.04.2012) The land is subject to the rights granted by a Deed dated 26 April 2012 made between (1) John Albert Cawley and Barry John Cawley and (2) National Grid Electricity Transmission PLC.
